This letter is in response to your inquiry regarding compliance of Carpenter Co. the following flexible polyurethane foam products with European Union (EU) Directive 2011/65/EU, Restriction of Hazardous Substances (RoHS) as supplied by Carpenter Co. Glossop Plant to Interpak Ltd:

RoHS 2011/65/EU restricts the use of lead, mercury, hexavalent chromium, polybrominated biphenyls (PBB), and polybrominated diphenyl ether (PBDE) to less than 0.1% by weight and the use of cadmium to less than 0.01% by weight in the manufacture of electrical and electronic equipment. Bis (2-ethylhexyl) phthalate (DEHP), butyl benzyl phthalate (BBP), dibutyl phthalate (DBP), and diisobutyl phthalate (DIBP) will be included in RoHS as of July 22, 2019.

Carpenter does not use or intentionally add the RoHS restricted substances in the manufacturing process for our flexible polyurethane foams listed above.


